13. COMMISSIONER RECUPITO AND FIVE FULL TIME EMPLOYEES ATTENDED THE TOIRMA SAFETY CLASS AND THE FLAGGER SAFETY TRAINING CERTIFICATION CLASS IN PLAINFIELD TOWNSHIP.
