11. REMOVED DEBRIS FROM BLOCKED CULVERTS ON RIECHERT DR. AND ANNE LN.
12. REMOVED DOWNED TREE IN THE ROADWAY ON KLEMME RD NORTH OF EXCHANGE ON 4/18.
13. 24626 KLEMME RD TREE REMOVAL UPDATE: I HAVE BEEN IN CONTACT WITH THE REPRESENTATIVE OF THE BANK SINCE LAST YEAR THAT HOLDS TITLE TO THIS PROPERTY ABOUT THE DAMAGED TREE REMOVAL. ALL THE TREES IN THE TOWNSHIP RIGHT OF WAY AS WELL AS ON THE PROPERTY HAVE BEEN REMOVED BY THE BANKS CONTRACTOR. THERE WERE APPROXIMATELY 40 MATURE TREES REMOVED. THERE WAS NO COST TO THE TOWNSHIP.
