1. EQUIPMENT MAINTENANCE IS ON-GOING.
2. MONTHLY BRANCH PICK UP.
3. COLD PATCH ROADS. MATERIAL USED, 3.06 TONS.
4. SIGN REPAIRS/REPLACEMENTS- COTTAGE GROVE AT BURRVILLE RD. (BLINKERSIGN).
5. GUARDRAIL SPRAYING OF WEEDS COMPLETED.
6. CULVERT REPLACEMENTS ( 30 )- GOODENOW RD., KURT LN., BENDING CREEK TR., RANA DR., BEMES RD., KINGS RD. (2), WILLOWBROOK TR (5), CHERY LN., PINE CT., POPLAR LN. (2), BURRVILLE RD., CREEKSIDE CT., MULBERRY LN., WILDWOOD CT., CEDAR LN (2), NORFOLK RD., RICHTON RD., SANGAMON ST. (2), KLEMME RD., WALNUT ST., ASHLAND AVE., AND COTTAGE GROVE AVE.
7. REMOVED LOG JAMS IN THE CULVERTS THROUGHOUT THE TOWNSHIP DUE TO THE FLASH FLOODING ON MAY 15<sup>TH</sup>.
8. BARRICADES WERE PLACED AT 23 LOCATIONS DUE TO THE WATER ON THE ROADS FROM THE FLASH FLOODING ON MAY 17<sup>TH</sup>- 18<sup>TH</sup>. CREWS WITH MACHINERY WENT OUT TO REMOVE CROP DEBRIS THAT WASHED ONTO THE ROADS AND LOGS BLOCKING CULVERTS.
9. STATELINE ROAD BOX CULVERT WAS INSTALLED SOUTH OF BURRVILLE RD.
10. TRUCK SAFETY INSPECTIONS COMPLETED.
11. NEW UNDERGROUND ELECTRIC LINES TO FUEL TANKS AND NEW GENERATOR FOR SOUTH BUILDING HAVE BEEN INSTALLED.
12. DANNE RD. BRIDGE UPDATE: CONSTRUCTION STARTED ON MAY 18<sup>TH</sup> AND IS PROGRESSING
