HIGHWAY COMMISSIONER'S MONTHLY REPORT MAY 9TH, 2018

- 1. EQUIPMENT MAINTENANCE IS ON-GOING.
- 2. BRANCH PICK UP.
- 3. SHOULDER STONE APPLIED AT VARIOUS LOCATIONS.
- **4.** CULVERT REPLACEMENTS (19)--ON STATELINE RD., KLEMME RD. (8), SANGAMON ST., OLD EXCHANGE ST. (2), BURRVILLE RD., GOODENOW RD., ASHLAND AVE., RIECHERT DR. (2), SHARON LN., AND ON OLD EXCHANGE DOGLEG.
- 5. RCP STORM SEWER PIPE WAS INSTALLED ON THE EAST SIDE OF STONEY ISLAND AVE. FROM EXCHANGE ST. SOUTH TO THE FIRST DRIVEWAY. THIS WILL ELIMINATE MAJOR EROSION PROBLEMS ALONG THE ROAD DURING HEAVY RAINFALL.
- 6. WEED CONTROLL WAS APPLIED AROUND ALL GUARDRAILS THROUGHOUT THE TOWNSHIP.
- **7.** PLOWS AND SALT SPREADERS WERE REMOVED FROM ALL TRUCKS AND STORED TILL WINTER. ALL TRUCKS WERE PREPPED FOR SUMMER PROJECTS.
- 8. ALL TRUCKS HAVE BEEN SAFETY INSPECTED.
- **9.** REQUEST FUND TRANSFER OF \$25,021.46 FROM ROAD AND BRIDGE FUND TO ROAD AND BRIDGE INSURANCE FUND.
- **10.** ATTENDED A MEETING WITH WCDOT OFFICIALS REGARDING PROPOSED IMPROVEMENTS AT THE INTERSECTION OF BURRVILLE RD. AND EXCHANGE ST. RESEARCHING AREAS WHERE FUNDING MIGHT BE AVAILABLE.

11. BURRVILLE RD. AT IL RTE 394 IMPROVEMENT UPDATE: EMAIL RECEIVED ON 4/18/2018 FROM IDOT STATED THE FOLLOWING:

CURRENTLY IN THE PHASE I PRELIMINARY ENGINEERING AND ENVIRONMENTAL STUDIES.

IMPROVEMENT IS NOT CURRENTLY INCLUDED IN THE DEPARTMENTS FY 2018-2023 HIGHWAY PROGRAM.

THE PROJECT WILL BE INCLUDED IN IDOT'S PRIORITIES FOR FUTURE FUNDING CONSIDERATIONS. THEY ARE PROPOSING A RESTRICTED CROSSING U-TURN (RCUT) INTERSECTION.

AN ADDITIONAL IMPROVEMENT INCLUDED WITH THIS PROJECT IS TO EXTEND THE SOUTHBOUND STORAGE LANE AT THE INTERSECTION OF IL RTE 394 AT EXCHANGE ST.TO ADDRESS KNOWN QUEUING PROBLEMS AT THAT INTERSECTION.
