CRETE TOWNSHIP BOARD OF TRUSTEES MEETING

June 10, 2020

The regular scheduled meeting of the Crete Township Board of Trustees was called to order by Supervisor Liccar at 7:00 PM.

Board members present via Zoom Conference were Trustee Elton, Trustee Hodge, Trustee Piancentini, Trustee Grady and Supervisor Liccar. Clerk Buitter was also present.

Pledge of Allegiance was given to the flag.

APPROVAL OF MINUTES: Motion to approve the minutes of the May 13, 2020 Board of Trustees meeting was made by Trustee Hodge, seconded by Trustee Elton. All were in favor, minutes stand approved as written.

Motion to approve the Special Board meeting approving the expansion of the phone system was made by Trustee Elton, seconded by Trustee Grady.

REPORTS:

Supervisor

Supervisor Liccar stated that the Will Ride buses are requiring face masks and sanitary wipes be used to keep the buses very clean. They are doing a very thorough cleaning after each day and keeping up with the sanitary requirements by the law.

Supervisor Liccar did bring up that Will County received grant money from the federal government to combat the COVID 19 virus. Some of this money will go to the Paratransit agency for the items needed to fight this virus.

It was also mentioned that the Town Hall will reopen on July 6, 2020. There will be placards showing where the 6 foot distance will be and face masks will be required.

Clerk:

Clerk Buitter brought up the fact telecommunications system that we will start installing that in two weeks or so.

Clerk Buitter brought the annual Town Hall meeting. We will be having the meeting on July 14, 2020 at 7 PM at the Town Hall meeting.

Highway Commissioner- Supervisor Recupito read his report. Equipment maintenance is ongoing. Monthly branch is happening. Cold patch is being done on the roads. Signs are being replaced. Shoulder

Plan Commission – John Rzymiski mentioned that there was a zoning change request to have more storage units on Dixie Highway. It will have 230 units and it will cover about 10 acres. It will be an industrial zoning request to I one classification. John said the he is waiting for the county to approve it.

Building and Grounds - Nothing to report.

Senior Transportation – Supervisor Liccar gave the report as noted above.

Youth – Trustee Piacentini mentioned that Crete Park District has a lot of activities for our youth.

Mosquito Abatement – Trustee Piacentini mentioned that birquets have been put out. It was mentioned that Bob the driver calls all the people who have breathing problems and informs that he is spraying, and the citizens are very thankful.

Senior & Special Events – No events happening till the Shelter in policy gets lifted. The Christmas party will be very special this year since there are no events this summer. It was mentioned that we should have a concert in the park.

OLD BUSINESS – It was mentioned that we will have a summer newsletter that we will offer to our advertisers 50 % off pricing just for this issue. Motion was made Trustee Elton, second by Trustee Grady.
