CRETE TOWNSHIP BOARD OF TRUSTEES MEETING

May 12, 2021

The regular scheduled meeting of the Crete Township Board of Trustees was called to order by Supervisor Liccar at 7:00 PM.

Board members present were Trustee Elton, Trustee Hodge, Trustee Piacentini, and Supervisor Liccar. Clerk Buiter was also present. Trustee Grady was not present.

Pledge of Allegiance was given to the flag.

APPROVAL OF MINUTES:

Motion to approve the regular Board of Trustees meeting on April 14, 2021 minutes made by Trustee Piacentini, seconded by Trustee Elton. All were in favor. The minutes stand approved as written.

REPORTS:

Supervisor

Supervisor Liccar stated that the ridership is at 221 rides. This is down by about 40% from a year ago. The cost rose to \$11.48 a ride versus a \$10.83 per ride a year. We are seeing a rise in ridership, so our costs are rising a little bit. That is great that we are seeing more people using the Will Ride program.

Motion was made to publish the budget of the Town Funds by Trustee Elton, seconded by Trustee Hodge. All were in favor. Roll Call was taken as follows: Trustee Elton – yes, Trustee Hodge – yes, Trustee Piacentini – yes, Supervisor Liccar – yes. Motion passes.

Motion was made to publish the budget of the Road and Bridge Funds by Trustee Elton, seconded by Trustee Piacentini. All were in favor. Roll Call was taken as follows: Trustee Elton – yes, Trustee Hodge – yes, Trustee Piacentini – yes, Supervisor Liccar – yes. Motion passes.

A motion was made to approve the building usage request from the Ridgefield Homeowner's Association Fund for November 4, 2021 6 PM- 9 PM by Trustee Elton, seconded by Trustee Piacentini. All were in favor. Roll Call was taken as follows: Trustee Elton – yes, Trustee Hodge – yes, Trustee Piacentini – yes, Supervisor Liccar – yes. Motion passes.

Supervisor Liccar brought to the attention that the township has robust social media presence on the internet. Supervisor Liccar has found an individual who does quality job in this arena and asked him to provide a proposal for his services. The goal to make our social media presence timelier and user friendly. Nick Borrelli proposed that Crete Township has a social media and website content. This proposal would include news and press releases of different events and newsworthy items. A motion was made to approve the retainer contract of \$1500 per month by Trustee Elton, seconded by Trustee



Placentini, seconded by Trustee Elton. All were in favor. Roll Call was taken as follows: Trustee Elton — yes, Trustee Hodge — yes, Trustee Placentini — yes, Supervisor Liccar — yes. Motion passes.

Supervisor Liccar brought up the fact that He has discussed to the Linden Group to start up the planning proposal. His contact said the previous proposal from 2019 did not go up and is the same price. A motion was made to hire the Linden Group for \$5800 to \$7975 to provide conceptual building programming by Trustee Elton, Seconded by Trustee Hodge. All were in favor. Roll Call was taken as follows: Trustee Elton – yes, Trustee Hodge – yes, Trustee Piacentini – yes, Supervisor Liccar – yes. Motion passes.

Supervisor Liccar brought up the flooding problems throughout Crete Township. There is a company that install a big cage and under the steel cage there is conduit that lets the beaver go through and keeps the debris and logs flowing through. This is very friendly to the beaver population. The Army Corp of Engineers must approve this procedure. He wants to keep the board update. This is addressing a problem that the residents of Crete Township did not want to handle.
