## **MONTHLY REPORT**

FEBRUARY 9TH, 2022

- 1. EQUIPMENT MAINTENANCE IS ON GOING.
- 2. PLOWING AND SALTING OF ROADS.
- 3. TREE TRIMMING AND REMOVAL ON STATELINE RD.
- 4. SNOWSTORM OF 2/1/22 AND 2/2/22 STARTED WITH FREEZING RAIN AND TRANSITIONED TO SNOW OVERNIGHT WITH SNOW FALLING FOR 12 HOURS STRAIGHT THEN TURNING TO BLOWING AND DRIFTING. APPROXIMATELY 12 INCHES OF SNOW ACCUMULATED IN OUR AREA DURING THIS EVENT. DUE TO THE DEDICATION AND HARD WORK FROM OUR CREW ALL OUR ROADS REMAINED OPEN.
- 5. WELL PUMP WAS REPLACED.IT WAS 44 YEARS OLD. REPLACEMENT COST \$1,350.00.
- 6. KINGS ROAD BRIDGE REPLACEMENT UPDATE: D CONSTRUCTION WAS AWARDED THE CONTRACT IN THE AMOUNT OF \$721,325.90 ON JANUARY 20<sup>th</sup>,2022. PRECON MEETING WAS HELD ON FEBRUARY 2,2022 WITH ALL THOSE INVOLVED WITH THE CONSTRUCTION. THERE HAS NOT BEEN A START DATE DETERMINED, BUT OUR INTENTION IS TO HAVE IT COMPLETED BEFORE MOTHER THERESA CATHOLIC ACADEMY RETURNS FOR SCHOOL IN THE FALL. THIS IS A 50/50 JOINT PROJECT BETWEEN THE ROAD DISTRICT AND WILL COUNTY DOT.
